

Manorial Records at Cambridgeshire Archives

Introductory Note

This handlist is chiefly derived from the subject index cards for manorial records, including those for un-catalogued manorial court rolls and books, supplemented from references in the Annual Reports and Accession Register. In relatively few cases have the records themselves been checked. Some inconsistencies are consequently inevitable, owing to unevenness of treatment of details in indexing over the years. "Minutes" in this list, for example, may be loose sheets or minute books; "court rolls" may in fact be in book form. So far as has been possible, however, minute books have been distinguished from minutes and court rolls from court books. Amendments to this list whilst in use will gradually refine it.

Copies of court rolls (i.e. extracts of admissions, surrenders, etc.) have been excluded intentionally. The dates given are covering dates and gaps may occur in a series though significant gaps of over 10 years have generally been indicated.

Where no record of a manor is given in this list due to the absence of manorial documents deposited here, information on the manors in a particular parish may be found in Lysons' *Magna Britannia* (1808) and the relevant volume of the *Victoria County History of Cambridgeshire*.

The Manorial Documents Register is the official register of manorial documents for England and Wales which The National Archives maintain on behalf of the Master of the Rolls. The Register contains information about the nature and location of surviving manorial documents. Records for Wales, Yorkshire (all three Ridings), Hampshire, Isle of Wight, Norfolk, Surrey and Middlesex.
